General Principles

Any licence which is issued in the name of a body corporate will provide only for ownership and possession of firearms by the Body Corporate. A Body Corporate Licence does not authorise handling, carriage and use of firearms by employees, nominated or responsible persons of the Body Corporate. Such persons must hold an appropriate individual Firearm Licence.

This form allows for bodies corporate (including incorporated associations) to apply for a Firearm Licence to:

- Allow approved shooting clubs which are bodies corporate (or incorporated associations) to own and possess (but not use) firearms for the lawful pursuit of the club;
- Operate in the security and prison industry;
- Engage in primary production;
- Engage in professional hunting; and
- Satisfy other official and commercial purposes or purposes provided for by the *Firearms Act 1996*.

Note: This form does not apply to a Licensed Firearms Dealer.

This Body Corporate Application should only be completed by:

1. Organisations which are registered with the Australian Securities and Investments Commission (ASIC)

Nominated Person

Responsible Persons

In the case of a Body Corporate. All board or club committee members must be listed in the application as Responsible Persons i.e. Director, President, Vice President, Secretary, etc.

N.B. The Nominated/Responsible Persons cannot possess, carry or use Body Corporate firearms unless they personally hold the appropriate Firearm Licence.

Personal Information Form

The Nominated or Responsible Person must complete and attach a Personal Information Form with this application, if they have not submitted either a Personal Information Form or do not hold a current Victorian licence.

Change of Nominated or Responsible Person

Where the Nominated or Responsible Person(s) changes during the course of the licence, Licensing & Regulation Division must be informed in writing, before the occurrence. A Personal Information Form and fingerprints must be provided for the replacement Nominated or Responsible Person.

Safety Courses

The Nominated or Responsible person(s) are required to hold the appropriate licence and complete the relevant longarms or handguns Firearms Safety Course, if that person(s) physically handles/uses or intends to handle/use firearms.

The Firearms Safety Course **must first be completed and the course certificate must be submitted with this application.**

• Category 2 Firearms Collectors Licence

Category 2 Firearms Collectors Licence allows you to own - **but not use** - unless the appropriate permit has been obtained

- Longarms; and
- Handguns that have been manufactured on or after the 1st January 1947; and
- Handguns that have been manufactured after the 1st January 1900, but no later than 31st December 1946; and
- Handguns that have been manufactured before 1900, that use percussion as a means of ignition and that take cartridge ammunition that is commercially available; and
- Antique handguns (that are not single shot antique handguns).

You must have held a Category 1 Collectors Licence for at least 2 years. You must explain and demonstrate that the firearms being collected are of obvious and significant commemorative, historical and thematic value. You must also possess more than 10 handguns manufactured before 1st July 1947 and show any additional handguns manufactured after 1st July 1947 will increase historical value of collection.

• Ammunition Collectors Licence

Allows you to own - **but not use** - ammunition which is rendered inert. Sporting or military ammunition up to 20mm in calibre does not have to be rendered inert. You must provide proof that you are a current financial member of an organisation of firearm or ammunition collectors, approved by the Chief Commissioner.

Firearm details:

Ramps, shrouds or similar protrusions are not to be included in the barrel length measurement.

Single Shot Pistols

The new minimum legal barrel length is 100mm.

Single shot pistols should be measured with the action shut.

Measurements should be taken with a rod from the breech face to the muzzle.

Ramps, shrouds or similar protrusions are not to be included in the barrel length measurement.
