Victoria Police Purchasing Category*

Uniform & Equipment – A broad range of uniform and related items, including firearms.

Information Technology – IT equipment and IT services that support operational policing and corporate support departments.

Radio & Telecommunications – Frontline communications, telecommunications, back-end communications and supporting equipment.

Transport – General and specialist vehicles used by the Police Airwing, Water Police, Bicycle Patrol Unit and others including cars, trucks, buses, trailers, etc.

Operational Support – Various goods and services required for operational policing, that are not covered by other categories.

Legal & Evidentiary – Goods and services involving specialist, legal, forensic or evidentiary knowledge and technology.

Custodial – Goods and services required to support the management of prisoners and police custodial functions.

Corporate Support – Common use goods and services used by any large organisation, including books and publications, professional development, advertising and promotion, mail, travel and accommodation.

Contractors & Consultants – All contractors, consultants and temporary agency staff.

Properties – Capital building projects, Accommodation Leasing, Building Maintenance, and related goods, works and services associated with buildings used and occupied by Victoria Police

staff.
