THE APPLICATION IS TO BE FORWARDED AT LEAST 28 DAYS PRIOR TO YOUR INTENDED ARRIVAL IN AUSTRALIA.

The information contained in your application is treated as Strictly Confidential

This permit only applies to category A, B firearms and category H handguns.

HOW TO USE THESE INSTRUCTION PAGES

There are six parts (Parts 1-6) in the application form:

- The form is to be completed in black or blue pen only.
- Attach copies of supporting documents securely to your application and forward to the appropriate issuing State or Territory.
- For any queries, contact the Firearms/Weapons Registry in your State or Territory. (Refer to back page)
- For Yes/No questions, please put a cross in the appropriate box.

PART 1 (A CERTIFIED CURRENT PASSPORT PHOTO OF THE APPLICANT MUST BE ATTACHED TO THE APPLICATION)

The **passport photograph** of yourself which you are required to supply with this application **must be certified** (signed on the back of the photograph) by an appropriate witness e.g. police, accountant, solicitor, doctor etc, must sign the photograph on the reverse, as follows; "true photograph of - your name, then the witness's name and signature".

If a **licence/permit** is required in your home country to possess, carry or use firearms a certified copy of this licence/permit must be attached to this application.

PART 2

If a Permit is required for **target shooting** on an approved range, please supply **a certified copy** of your shooting club membership or an invitation from an approved shooting club in Australia inviting you to shoot on their range.

If you wish to **shoot on private property**, you must attach a letter from the property owner or occupier giving permission to discharge a firearm on that property. This letter must include the size of the property, the property owner's name, address, date of birth and contact phone number.

If you wish to enter Australia for **hunting or a Safari Trip**, you must provide the name and permit number of the Safari tour operator or the name and address of the approved hunting club and location of hunting activities.

Firearms Details:

- For combination firearms, both calibres must be supplied example 12G (12 Gauge) & .22 (22 Rimfire)
- A correct serial number, appropriate to the make and model of the firearm, must be supplied. (Take care to avoid part numbers or product numbers on grips etc. INVALID NUMBERS WILL DELAY YOUR APPLICATION.
