APPLICATION TO BE AN AUTHORISED MEDIA ORGANISATION

Part 13 Division 3 (Agency photographs) of the Victoria Police Act 2013 (the Act) allows authorised media organisations to apply to Victoria Police for the release of Agency Photographs of guilty offenders. Prior to making such an application, an organisation or individual must apply to be classified as an 'authorised media organisation' under s236 of the Act. Only 'authorised media organisations' are entitled to apply for the release of Agency Photographs.

Only 'media organisations' are entitled to be classified as an 'authorised media organisation' under the Act. A 'media organisation' is defined by the Act as meaning a person or body who engages in journalism. Journalism is defined by s235 of the Act.

This form is to be used by a media organisation that is applying to become an authorised media organisation under the

Should the application be successful, further applications may be made for the release of an agency photograph to the authorised media organisation. Should the application be unsuccessful, the prescribed processing fee will not be refunded.

Section 2: Acknowledgement of Applicant

In making this application under s236 of the Victoria Police Act 2013, you acknowledge the following;

- That your organisation conducts journalism as defined by s235 in the Victoria Police Act 2013;
- That if granted, an authorisation will be given to you in writing in accordance with s238 of the *Victoria Police Act* 2013, and that the authorisation is made strictly subject to any conditions as specified on the authorisation;
- The applicant must fully comply with the authorisation, and that failure to do so constitutes a criminal offence under s242(1) of the *Victoria Police Act 2013*;
- That should you, the applicant, breach the requirements contained within s242(1) of the *Victoria Police Act 2013*, Victoria Police may revoke the authorisation of the applicant in accordance with s242(3) of the Act;
- That as prescribed by s242(2) of the *Victoria Police Act 2013*, it is a criminal offence to use an agency photograph provided by Victoria Police in any way except for the following;
 - (a) in the course of journalism carried on by the organisation;
 - (b) in accordance with the authorisation under s238 under which the photograph is given to the media organisation; and
 - (c) in accordance with i) any applicable privacy standard published or determined by the Australian Press Council or, ii) any applicable code published or determined by, or registered with or notified to the Australian Communications and Media Authority, established under the Australian Communication and Media Authority Act 2005 of the Commonwealth.
- That should you, the applicant, at any time breach s242(2) of the *Victoria Police Act 2013*, Victoria Police may revoke the authorisation of the applicant in accordance with s242(3) of the Act.
