General instructions for completing this application

Who should complete this application?

This application for a Chief Commissioner's Prohibited Weapons Approval is only to be completed by persons and/or organisations that are a:

- (a) Body corporate; or
- (b) Partnership; or
- (c) Sole trader

and who want to establish a business and:

- (a) bring into Victoria; or
- (b) manufacture, sell or purchase; or
- (c) possess, use or carry; or
- (d) arrange for someone else to bring into or send to Victoria

Prohibited Weapons as defined in the Control of Weapons Act 1990 and Control of Weapons Regulations 2011.

Or

Vary the weapon type, purpose or reason on an existing Chief Commissioner's Prohibited Weapons Approval or existing business, body corporate, partnership or sole trader business arrangements.

Please note:

- If the business is structured as a body corporate the Nominated Person must complete this application form.
- If the business is structured as a **sole trader or partnership** the sole trader or one of the partners must be appointed as the Nominated Person and complete this application form.

How do I complete this application?

- Each part of this application must be completed unless directed otherwise.
- Each part of the application has a corresponding instruction page section. Please read the instructions carefully and provide the documents and evidence as requested to avoid any delay in the processing of your application.
- Do not send original documents send <u>certified copies</u> only.
- All documents must be certified as true copies of the original and must be of the highest quality (i.e. all text is legible, and photos are clear) otherwise your application will be returned.
- If this is a variation to an existing Chief Commissioner's Prohibited Weapons Approval you will need to attach a
 copy of the existing approval with the changes noted and complete and supply the documents as outlined in this
 application.
- Send the application and supporting documents to the address listed at the top of these instruction pages.

Where can I get more information?

The Control of Weapons Act 1990 and Control of Weapons Regulations 2011 regulate prohibited weapons within Victoria. It is expected that you have a thorough understanding of the requirements of this legislation. The legislation is available on the internet at the Victorian Law Today website: www.legislation.vic.gov.au.

Part 1 - Type of application

- 1. Please indicate by placing a cross in the appropriate box whether you are applying for a new application, or changing the type of prohibited weapons, purpose or reason of an existing Chief Commissioner's Prohibited Weapons Approval.
- 2. Indicate whether you hold a current Firearm or Private Security Licence or Chief Commissioner's Prohibited Weapons Approval and record the licence or approval number (if applicable).

Part 2 – Required documentation (all applicants must provide the following information)

- 1. Personal Information Forms. These must be provided for all people relevant to the business including:
 - sole traders
 - each partner
 - the nominated person
 - all officers of the body corporate, and
 - all employees who will be handling or have access to prohibited weapons.

Note: Employees are exempt from holding an approval if acting in the course of their employment and in accordance with their employer's CCP approval. The employee cannot have access to prohibited weapons if they are a Prohibited Person. Licensing & Regulation Division's website (www.police.vic.gov.au/firearms) explains what a 'Prohibited Person' is.

The Personal Information Form is a separate form that can be downloaded from www.police.vic.gov.au/weapons by selecting 'Application and permits' and then 'Business Personal Information Form' for a Chief Commissioner's Prohibited Weapons Approval', or by contacting Licensing & Regulation Division. Persons completing this form must submit proof of their identity, answer all medical and criminal history questions and provide the documents outlined. Personal Information Form(s) **must be** submitted with Business Applications.

- **2. Standard Operating Procedures.** You must provide copies of your Standard Operating Procedures and protocols for prohibited weapon-related activities. These should cover all employee responsibilities, your responsibilities as an employer and the legislative requirements. It must include:
 - Details of how you will monitor and confirm whether your employees are not Prohibited Persons.
 - Who will advise Licensing & Regulation Division of any changes to staff and submit the Personal Information Forms for new employees as well as how you will ensure this is done within seven days of the change/person starting?
 - The procedures your employees will follow in relation to the daily management of weapons (display, access, storage, instances of unauthorised access etc). This should be in line with the employer's responsibilities, legislative requirements and the purpose, reason and weapon types of your approval).
 - The measures you have in place to ensure the security of the premises as well as any measures designed to prevent unauthorised access to, and theft of, prohibited weapons.
 - The procedures in place to identify that any persons/organisations wanting to buy or dispose of a prohibited weapon are not minors and hold a Chief Commissioner's Approval or Governor in Council Exemption for the prohibited weapon(s) type they want to buy/dispose of (refer to the *Control of Weapons Act 1990*, Section 5A).
 - The procedures for recording prohibited weapons sales and the format of your paper and/or electronic records. This
 should also include details of how you will ensure the safe keeping of these records and the back up measures you
 have in place in the event the records are destroyed (refer to Control of Weapons Act 1990, Section 5B and Control
 of Weapons Regulations 2011, Section 10).
- 3. Business plan. You must provide a business plan outlining the precise details of your business including:
 - The nature of the prohibited (and other controlled) weapons that will be handled by the business.
 - An explanation of the business' intention to purchase, import, possess, display, advertise, carry, use, manufacture or sell prohibited weapons.
 - The customers you intend to target when selling prohibited weapons.
 - Your advertising and marketing methods whether print-based or online.
 - The measures taken to secure weapons held on the premises particularly if the premises are a private residence.
 - The number of employees you intend to employ (Personal Information Forms will be required for each employee).

The training and supervision you will provide to employees dealing with prohibited weapons.

- 4. Business registration. You must provide certified copies of:
- The certificate of registration of the company; and
- Proof of the appointment of directors (e.g. a current and historical extract can be obtained from the Australian Securities and Investment Commission); and
- The current certificate of registration of a business name from Consumer Affairs Victoria for any trading names the company will operate under.
- 5. Evidence of public liability insurance (i.e. a copy or certificate of the currency of public liability insurance)
- **6. Evidence of financial viability.** You must supply a letter from a qualified accountant that provides an assessment of the financial viability of the business in order to satisfy the Licensing & Regulation Division that you have sufficient financial resources to conduct the business.
- **7. Employer Responsibilities.** A written undertaking signed and dated by the applicant or nominated person stating that they are aware of their obligations as an employer in relation to award wages, superannuation, taxation and occupational health and safety.
- **8. Council Clearance.** Provide a letter from the council or town planning authority that states that it does not object to the establishment of your business at the address(es) provided in your application or to the business trading in the prohibited (and/or other) weapons specified in your application.

All the documents you are required to submit for this part must be certified as true and correct copies of the originals.

Part 4 – Statement of Related People

Part 5 - Storage

Storage requirements

Prohibited weapons owned or possessed under a Chief Commissioner's Prohibited Weapons Approval must be stored in the following manner:

Imitation firearms (including laser/infrared devices) are to be stored safely and securely in a manner to ensure that:

- The devices are not readily accessible to others
- The devices are not available for possession, carriage or use by others unless they are also holders of a Chief Commissioner of Police Approval (Prohibited Weapons) issued for the same reason or are otherwise exempt (if applicable), and
- When being transported between the usual place of storage and place(s) at which the devices are legitimately used (the reason of which is stated in this authority), they are stored in a manner that is not readily accessible to others and concealed from plain sight.

Blow guns may be on open display in the approval holder's home, but both ends must be sealed, and all darts surrendered.

Body armour must be stored in safe and secure manner.

Swords must be stored in a manner to ensure that they are **not**:

- readily accessible to anybody other than holder of the Chief Commissioner's Prohibited Weapons Approval or Government in Council Exemption, or
- available for possession, carriage or use by a person who is not a holder of a Chief Commissioner's Prohibited Weapons Approval or does not fall within another class of exempt person.

General category crossbows must be store in a manner to ensure that they are not:

a. readily accessible to anybody who is not a holder of a Chief Commissioner's Prohibited Weapons Approval or <u>does</u> <u>not</u> fall within another class of exempt person. Specifically, the crossbows must be:

- i. fitted with a trigger lock and the keys stored in a separate place, or
- ii. stored with a cable lock through the foot claw and connected to the string, or
- iii. stored in the unstrung condition with the prod/bow assembly demounted from the stock (where possible),
- available for possession, carriage or use by a person who is not a holder of a Chief Commissioner's
 Prohibited Weapons Approval or does not fall within another class of exempt persons.

 Other prohibited weapons should be stored in a locked cupboard, cabinet or safe of sturdy construction.

Other prohibited weapons should be stored in a locked cupboard, cabinet or safe of sturdy construction. If the storage unit is glass fronted, the glass must be at least 5mm thick. If the mass weight of the storage unit is less than 150kg, it must be affixed to either the frame of the floor or wall (where applicable) so as to prevent easy removal. Wood screws and similar are not acceptable; however, ramset/dyna bolts are enough. The locks fitted to these storage units must be of sturdy construction. Padlocks must have shanks of hardened steel.
