**VICTORIA POLICE FEES & CHARGES
AS DETERMINED BY POLICE REGULATION (FEES AND CHARGES) REGULATIONS 2024**

EFFECTIVE FROM 1 JULY 2026

Fees and charges are officially set and revised by legislation relevant to their application. The Victorian Government has a policy of automatically indexing certain fees and fines each year for inflation, so that the value of those fees and charges is maintained. This document outlines the fees and charges for the purposes of:

- personnel and resources deployed to sporting entertainment and other events where user charges are applicable.
- providing information or services as a defense witness in a criminal proceeding or as a witness for any other party in a civil proceeding.
- searching for relevant police files and providing information from those files or supervising the examination of files.
- or providing information or services in an interview by a member of the public about an incident or accident reported to the Police Force including a search for files.
- providing a sworn affidavit and
- calculation of restitution to Victoria Police for false reports made by members of the public.

Note: Fees and charges for Control of Weapons, Firearms License and Permit fees and Private Security license and registration fees are excluded from this list.
